## Medical Liability Agreement

Participants will be covered by the Youth for Christ supplemental medical and liability insurance during the published date(s) of the event. This policy functions as a secondary policy; any claims arising during the event are first filed with a participant's primary insurance carrier. The Youth for Christ policy then covers any expenses not covered by the participant's primary insurance up to the limits of this policy.

If a participant requires medical attention while during the event, they are responsible for obtaining a detailed statement from the health care provider, including their name, diagnosis, description of service, date of service, and charges for service. This is to be filed first with their primary provider. If a participant does not have primary insurance, or if the participant's primary carrier does not cover all of the expenses, then contact Youth for Christ International for filing instructions.
